



Charles Edward Green

November 25, 1933 - October 2, 2013

Charles Edward Green, 79, of Fort Payne, Alabama passed away Wednesday, October 2, 2013. He was born November 25, 1933, in Haralson County, Georgia. In 1942, his family moved to Anniston, Alabama where he attended public school and graduated from Anniston High School in 1951.

Charles Enlisted in the U.S. Navy and was sent to Korea where his ship ferried ammunition to U.S. Marines in Korea and repatriated POW's back to Japan. In 1954, he assisted with the French evacuation of Nuns at Dien Bien Phu, North Vietnam. He served on a Destroyer in the Mid East and an Air Craft Carrier which participated in the beach landing of U.S. Marines at Beirut, Lebanon in 1958. Following his Honorable discharge from U.S. Naval service, Charles attended the University of Alabama and graduated in 1962, with a BS in Electrical Engineering.

His 32 year career in the paper industry began when he joined St. Regis Paper Co. as a Corporate Engineer, and later retired from Champion International Paper. He designed and built paper mills across North America, including management of a Multi-Million dollar mill in Alberta, Canada. The final project of his career was spent in Brazil. During his career, Charles maintained offices in Florida, Washington, Minnesota, South Carolina, Texas, Ohio, North Carolina, Connecticut, Amapa, Brazil and British Columbia and Alberta, Canada. He was a registered Professional Engineer in 7 States and

Canada.

Charles designed, developed and implemented a project management training program and led company-wide training seminars for over 1,000 employees. He obtained several patents and authored a number of professional documents, including engineering, procurement and construction contracts which revolutionized contracting relationships within the paper industry.

Charles was an active member of IEEE and chaired one IEEE Pulp and Paper Conference.

Following retirement from Champion, Charles joined Smurfit-Stone, and managed their Capital Projects program.

Charles was a member of the Sons of Confederate Veterans, the Military Order of Stars & Bars, the Sons of the American Revolution, the Order of the Founders and Patriots of America, The Sons & Daughters of the Pilgrims, The Cherokee Nation and Rotary International, as well as local Posts for the V.F.W. and The American Legion.

Charles was a member of St. Philips Episcopal Church of Fort Payne, Alabama.

He is survived by his wife of 51 years Betty Green, son Charles F. Green and wife Angela of Jacksonville, NC; daughters Laura A. Green of California and Susan E. Green Fairbairn and husband Hugh of Atlantic Beach, Florida.

Memorial services will be held at 11 A.M. Saturday, October 5th at St. Philips Episcopal Church with the Rev. Judith Comer officiating. Visitation will be held prior to the service, beginning at 10:15 in the Parish Hall. Interment will follow

at a later date in the Alabama National Cemetery in Montevallo, Alabama.
